KINTYRE WAY RECEIVES VITAL FUNDING FROM RES

One of Scotland's most scenic walking routes has received vital funding from a renewable energy company.

British renewable energy company RES, who this week submitted a planning application to Argyll and Bute Council for Freasdail Wind Farm near Whitehouse, has committed to providing £30,000 of funding to the Kintyre Way.

The funding for the Kintyre Way will be split into £10,000 each year, for the next three years.

Owen Paisley, Kintyre Way Route Manager, said: "I am very pleased to enter into this sponsorship agreement with RES. The funding provided will go a long way to ensure the future viability of the route so that it can continue to bring benefits to all of Kintyre.

"Since 2006 it is believed that around 6000 people have walked down the Kintyre Way bringing almost £2.5 million into the Kintyre economy. Unfortunately, none of this financial benefit returns to the Kintyre Way to help with maintenance and development. Without the financial lifeline offered by RES there was every possibility that the route would have to close in 2013. With this funding in place the board can now continue their work in building up the route as a world class walking destination."

Louise Davis, RES Development Project Manager, said: "We know how valuable this funding will be in helping to sustain the Kintyre Way and to attract further investment. The local benefit the organisation brings to the area in terms of tourism and support for the economy is vital. As a company wishing to develop in the area we want to make sure we are contributing to the future of Kintyre in as many ways as we can. We hope the Kintyre Way continues to attract tourists to the area so they can explore this beautiful part of the country."

RES has consulted extensively with the local community on its proposal for the 11-turbine Freasdail Wind Farm. The company held public exhibitions, issued a newsletter to 1526 houses and businesses, formed a Community Liaison Group and held meetings with local residents and representatives from the community councils.

If the wind farm is consented, RES will provide a community benefit fund to support organisations and good causes based in the communities close to the wind farm for the lifetime of its operation. The company is currently talking to the local community about how the funds could be spent.
